STEADFAST connections

SOLID APPROACH

FSG provides intervention and treatment through a systems approach. This model differs from the traditional private practice therapy paradigm of 50-minute counseling sessions. We treat the whole family in order to effect positive change with the individual and their surrounding family. This holistic care approach better serves the family unit.

The systems approach requires therapist case management outside the traditional counseling sessions and may include community and school outreach, collaboration with clinicians and ongoing follow-up with family members. This type of case management is not fully covered by the counseling session fee.

HOW WE HELP

- Family, couple, individual, and youth counseling services available at a sliding scale (reduced fee determined by income) and at no charge to the unemployed
- 24-hour crisis intervention in cooperation with Glencoe Public Safety
- Alternatives to Violence program
- Youth, parent and school outreach
- Professionally-facilitated parent support discussion groups through Glencoe Parent Connection (GPC)
- GPC "We Need to Talk" programs (all age ranges)
- Confidential scholarship assessment
- Senior housing assistance
- Information and referral
- Staff-led focus group series for parents of preschoolers
- Mindfulness and yoga workshops
- Promotion and sponsorship of social-emotional programs such as Family Action Network (FAN) events
- Community-wide needs assessment
- Community education on FSG's centennial history and current services

FSG continues a long tradition of providing services **for all who live or work in Glencoe**. Our practice is made up of experienced, highly-skilled clinicians who help individuals, families, couples, children and adolescents.

NEW THIS YEAR

Parent Consultations provide parents with a one-time consultation or a brief series of consults that are solution-focused, address specific issues and may include referrals. Parents gain knowledge, skills and insights for resolving their concerns. Consultations are tailored for each parent with the goal of maximum results in minimum time.



We also opened a second clinical office on Park Avenue in Glencoe to expand counseling services and further protect the confidentiality of our clients.

GLENCOE PARENT CONNECTION (GPC)

A parent-powered, community outreach program of Family Service of Glencoe, GPC connects parents with parents, schools and resources to help us raise emotionally healthy kids within a supportive community.

GPC events are organized by a dedicated group of parent volunteers from the preschool, South, West and Central school communities. These programs, entitled "We Need to Talk," are supported by FSG's youth and family team with clinicians on-hand for all events.

GPC offers grade-level-based parent discussion groups to encourage positive conversations around social-emotional issues. New groups are being formed to meet the needs of parents of five and six-year-olds.

COMMUNITY PARTNERS / FSG collaborates locally to provide programs and services: Glencoe Historical Society, Glencoe Junior High Project, Glencoe Park District, Glencoe Public Library, Glencoe Public Safety, Glencoe School District 35, Glencoe Youth Services, New Trier High School, North Shore Exchange, Reach Yoga, Committee for Senior Housing Aid, Village of Glencoe.



ALTERNATIVES TO VIOLENCE PROGRAM

Our Alternatives to Violence (ATV) program is a 26-week psycho-educational group targeted at males who have an anger problem or who have been perpetrators of partner abuse. This program is staffed by a male and female facilitator who have completed 40 hours of state-approved domestic violence training and an additional 20 hours of training in working with perpetrators of domestic violence.

CRISIS INTERVENTION

FSG provides on-call crisis intervention services in partnership with Glencoe Public Safety. Our crisis counselors are available 24 hours/7 days a week to consult with and immediately intervene in the lives of some of Glencoe's most vulnerable families. FSG provides immediate assistance, appropriate referrals and follow-up services. This proactive approach assists our Public Safety officers in effective interventions and assists our Glencoe families in adaptively coping with the crises that affect their lives.

EMERGENCY RESPONSE

Family Service of Glencoe is an emergency-crisis responder in the event of a tragedy in our schools, businesses or homes. FSG has systems in place to efficiently mobilize the entire staff if unforeseen trauma comes to our village. Through our emergency response planning, we are proactively prepared to care for the Village of Glencoe during any of the challenges life can bring.

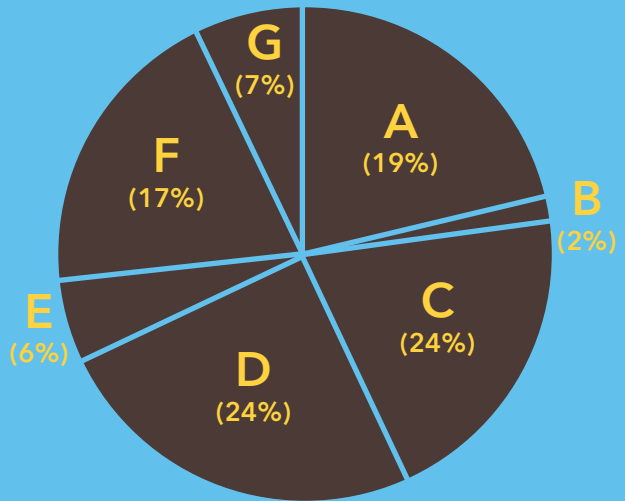
FY14 FINANCIAL OVERVIEW

- G - North Shore Exchange (7%)

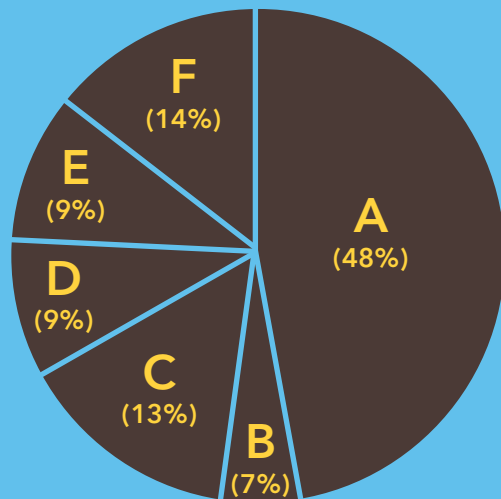
TOTAL REVENUES: \$784,455

PERSONAL IMPACT

- Provided services to 2,264 community members
- 52% of counseling services were provided on a sliding fee scale (average fee paid by sliding scale clients: \$30)
- Distributed \$17,500 in senior housing assistance, helping 9 long-time Glencoe residents to keep their homes
- Assisted Glencoe Public Safety on 51 crisis calls
- Hosted 16 monthly parent discussion groups
- Counseled and supported 18 men to complete the Alternatives to Violence program
- Championed the needs of 37 individuals through the Salvation Army and Clergy Fund assistance program
