Over the past few years, our community has experienced trauma from sources that have only compounded the individual issues we already face. Unfortunately, there is no perfect handbook to help us navigate these challenging experiences—from a global pandemic, a mass shooting in nearby Highland Park, and personal challenges and struggles, we have collectively leaned on one another to find a way forward. Yet, while a single event can last a few short seconds or minutes, it is the incessant and chronic reverberations from that experience that can have long-lasting impact. As much as we can assist one another, there are times when more experienced support is necessary.

Thanks to the generosity of donors and the strong collaboration of partners, Family Service of Glencoe remains a vital resource for the community to address these personal and collective experiences. This year has been about helping those in need find their way to FSG and ultimately to social, emotional, and mental wellness.

In 2022, the need for mental health services continued to rise as more individuals recognize their need and reach out for support. In the past year, our services have returned to in-person counseling, in addition to the telehealth option. We continue to respond to the most urgent counseling needs and crisis calls, and older adult services continue to expand to address issues of isolation and memory care.

The following pages represent FSG's core programs and how we have responded to the evolving needs in 2022. Thank you for joining us on this journey as we help individuals, families, and the community navigate these experiences. We are honored and grateful for your partnership and support to ensure that FSG remains responsive to community needs.

A message from our Executive Director Amber Bond, CCMHC, LCPC, PMH-C

At this time last year, the US Surgeon General had just released an advisory on Youth Mental Health, citing trends that we see here in Glencoe and the surrounding communities: increased diagnosis of mental health disorders, increased reports of sadness and hopelessness in high school students, and increasing thoughts of suicide in youth. These concerns coming out of the pandemic were compounded by the tragic shooting in Highland Park.

FSG leapt into action on July 4th to provide accessible, free, confidential services to anyone in our community or its neighbors who had been impacted by the shooting. Since then, we continue to see an influx of need, particularly among young people and their caregivers for a wide range of concerns. Many of these new cases are more complex than prior to the pandemic, involving coordination of care with schools, psychiatrists, and intensive outpatient or hospital programs. We have been able to meet these community needs with limited wait times and collaborative, client-centered care.

In October, the US Surgeon General released a framework for supporting mental health in the workplace, noting that 76% of US workers reported at least one symptom of a mental health condition. The wellbeing of the Glencoe workforce is also a top priority. We continue to serve those that make Glencoe and the North Shore such a remarkable place to live. Our workforce is on the front lines caring for our children, providing essential services, enhancing our quality of life, and responding to crises. FSG, in turn, has been there this year to help them manage the increased stressors and major life changes caused by the pandemic, the Highland Park Shooting, and more.

Today, the pace of inquiries for new services shows no signs of slowing. Thanks to the support of the community, FSG will continue to be here to meet the need. Whether that call is from the parent of a Kindergartner who is struggling with tearfulness and tummy aches at school drop off, the grandparent of a teenager struggling with an eating disorder, a couple going through a divorce seeking consultation about how to support their kids, or a retiree looking for support as they adjust to life after work, FSG can (and will) be here help.

Mental Health First Aid Training



In 2022, Tara Bagnola, MSW, FSG Staff Therapist, and Emily Mysel, LCSW, FSG Senior Program Manager, completed their certifications as Mental Health First Aid Instructors, allowing them to provide Mental Health First Aid training. In-line with their clinical interests, Tara's certification was on the adolescent track, focusing on teaching adults how to recognize signs and symptoms of mental health and substance use problems in adolescents ages 12-18, provide them with skills to help young people in both crisis and non-crisis situations, and reduce the stigma associated with mental health challenges. Emily completed her certification in training adults to identify the same issues in other adults.

Special thanks to our friends at The Josselyn Center for sponsoring their training in this program, facilitated by the National Council for Wellbeing.

Crisis Response

Family Service of Glencoe partners with Glencoe Public Safety to provide psychological support to families in crisis around the clock. Our crisis team is on call 24 hours a day, 7 days a week, 52 weeks a year. We are available to care for Glencoe residents and business in response to:

- A home fire
- An incident of domestic or family violence
- A child or adolescent emotional crisis
- An elderly resident in need of assistance
- A sudden death of a family member We have close ties to other supporting emergency organizations who can also help in times of crisis, such as the North Shore Senior Center, Haven Youth and Family Services, and Highland Park Hospital.



FSG Responded to 61 crisis calls during our 2022 Fiscal Year.
Thirty (30) individuals received one free consultation or three
counseling sessions following the crisis call.

Clinicians on our diverse team each bring their expertise in different specialties, including:

- Family Therapy
- Children/Adolescents
- Young Adults
- Older Adults
- Parinatal Mental Health
- Play Therapy

- Divorce
- Grief and Loss
- Domestic Violence/Sexual Assault
- LGBTQ+
- Services for Spanish Speakers





Our community faced an unimaginable shock and loss on July 4, 2022, when our neighbors and friends in Highland Park became victims to gun violence, and we continue to heal from the devastation. Recognizing that this tragedy affected people both in and beyond Highland Park, FSG offered free drop-in counseling sessions, workplace and community education and processing workshops, support for our public safety partners, and traditional psychotherapy for those experiencing long-term distress related to the shooting.

We recognize, however, that healing ourselves and repairing our communities from a tragedy like this will not be a straight line, and there will be ups and downs in the coming months and years. As such, FSG is poised to continue providing care to our community through easily accessible services. Our therapists have immediate availability to provide counseling to anyone in need, and we will continue to leverage our partnerships with Glencoe Public Safety, Glencoe School District 35, New Trier Township, local clergy, and beyond to provide counseling services, Mental Health First Aid training, and community education, where needed. 

In an effort to meet the needs of our senior adult community in Glencoe, Family Service of Glencoe is proud to partner with The Village and Public Safety Department to help ensure the well-being of all our residents (65+). Emily Mysel, Senior Program Manager at FSG, is a designated Senior Services Officer (SSO), working alongside her community SSO partners to provide the following services to Glencoe seniors:

Well-being Checks - At any point if there is concern about a family member, friend, or neighbor and you would like Glencoe Public Safety to complete a well-being check, you can call to request an officer go out to the home to check the person's status.

Referral Services - Not sure where to look for services? FSG has a wealth of referrals to assist with most anything an older adult would need.


Assistance for Seniors -The Committee for Senior Housing Aid in Glencoe has helped keep Glencoe seniors in their homes for more than 30 years by providing small grant awards to Glencoe seniors who meet the program's asset and income criteria to help them pay their property taxes or monthly rent.

Older Adult Consultations - Family Service of Glencoe's Older Adult Consultations provide the opportunity for Glencoe Seniors and/or their families to meet with a licensed clinical social worker who specializes in the aging continuum to provide support, therapeutic interventions, education, resources, and referrals. Initial consultations are 1 to 1.5 hours in length with ongoing support, as needed. Appointments are available Monday through Thursday 9:00 am to 5:00 pm.

Support, education, and follow-up after telemarketing fraud, scams, identity theft, abuse/neglect and financial exploitation.

Glencoe Cares - In partnership with Glencoe Public Safety, the Glencoe Cares program helps provide Glencoe seniors with additional support when receiving emergency assistance.

FSG also supports the community's aging population with **Dementia Education and Support, Wandering Interventions and Safety Steps, and Outreach Events.**

Dementia Friendly Glencoe

In partnership with the Village of Glencoe, FSG became a Dementia Friendly Community in 2019. The goal of this initiative is to create a welcoming and inclusive community for those living with dementia through advocacy and education. Emily Mysel, FSG's Senior Program Manager, leads the charge to ensure our community is equipped to support people living with dementia and their caregivers.

This past year, FSG became a memory screening site through the Alzheimer's Foundation of America. A memory screening is a safe, easy, and confidential "check-up" of a person's memory and thinking abilities. The screening consists of a quick and short series of questions and tasks that help to determine if a more comprehensive evaluation should be scheduled. A memory screening is not used to make a diagnosis but used to be a safe space to consult and address concerns someone may be having regarding his/her cognition. In addition, referrals and supportive services will be available for the individual and/or the loved one.

Vibrant Living Group

Each month Joan Merlo, LCSW, FSG Staff Therapist, leads the popular Vibrant Living Senior Discussion Group, focusing on finding meaning, balance, and resilience in the struggles, joys, and intergenerational politics at this most important stage of life. Joined by yoga instructor Judy Roin, participants can find balance through discussion, stretches, breathing, and balancing exercises. We understand that many seniors in our community have a need to nurture their connections, and Vibrant Living is the perfect place to come together for support, conversation, and inner balance.

FSG's Senior Housing Program supports low-income senior residents of Glencoe to age in place, so they may remain in their community. For those meeting residency and income criteria, FSG provides monthly financial assistance. In addition, case management services are incorporated that help to assess needs, provide referrals, and connect with additional supportive services. FSG partners with Rebuilding Together, a nonprofit organization, to provide home repairs at no cost to seniors receiving FSG's financial assistance.
